When can I meet with an attorney?

First time clients or clients with new cases should call us between 9 AM and 5 PM, Monday through Friday, for an intake interview.

What if you cannot take my case?

If we cannot take your case due to high caseload or limited resources, we will do our best to make appropriate referrals to trusted legal and social service agencies.

Is there a fee for your services?

There may be a \$25 consultation fee for immigration cases. If we are able to accept your case, we may charge a minimal fee, depending on the type of service provided. However, no one will be denied services for the inability to pay.

Has the U.S. Congress passed comprehensive immigration reform?



CITIZENSHIP

Reasons to become a U.S. citizen include:

voting rights, protection from deportation, eligibility for petitioning for other family members to come to the U.S., traveling outside the country without a time limit, qualifying for federal employment, and many more!

To be eligible, you need to:

- be at least 18 years old
- speak, read, and write *basic* English
 - English is *not* needed for citizenship if:
you have a physical disability, are at least 50 years old and a green card holder for 20 years, **OR** at least 55 years old and a green card holder for 15 years
- Have had your green card for at least 4 years and 9 months
OR
Have had your green card for at least 2 years and 9 months **AND** be married to a U.S. citizen

Application Process:

1. File your application
2. Fingerprinting
3. Interview and citizenship exam
4. Oath ceremony
5. Register to vote!
